*Membership dues are based on employee count. Employees are defined as any person scheduled to work 40 hours or more per week, including the owner(s). Minimum employee count is one. Part-time employees scheduled to work less than 40 hours per week should be counted as one-half employee.*

Service Clubs ~ Non Profits	\$ 50.00
Civic Memberships ~ Non Business	\$ 50.00
Subordinate Associate ~ Licensed Agents	\$ 65.00

*Subordinate Associate is defined as an individual with a special license (such as real estate agents) that is only active if it is held by a larger agency (such as a Broker). The associate fee only applies as long as the "larger agency" is a member in good standing at the full business membership fee.*

Quarterly or semi-annual payments may be considered on a case by case basis
