- Parade Assembly is at 4pm in front of Lake Isabella post office. Judging is between 4:30 and 5:30pm. Winners will be announced at the start of the parade.
- It will be dark. Please keep safety in mind. **Given the darkness, please do not throw candy or other items from your float or vehicle.**
- Please consider playing festive Christmas music. Music adds a lot to a parade and makes it fun for all.
- Keep a spacing of 50 feet between entries. Designate someone to monitor spacing and inform drivers if they are getting too far ahead.
- Please do not have any Santas as part of your group – the only Santa in the parade should be the one on the last float. However, Mrs. Claus, elves, the Grinch and others are all fair game! 😊
- The parade will take place “rain or shine.”
